

SAN BERNARDINO INTERNATIONAL AIRPORT AUTHORITY

AIRPORT FEE SCHEDULE – Amended September 23, 2009 FISCAL YEAR 2009-2010

Except when a valid agreement or lease provides otherwise, the following Fee Schedule shall apply to all airlines, both passenger and cargo carriers, and all other Airport users as applicable. This Fee Schedule is subject to annual revisions.

(1) Fees are due and payable on the first day of each month. Fees will be considered delinquent fifteen (15) days after due date. Ten percent (10%) of gross lease administrative charge will be imposed to cover Airport costs incurred in processing delinquent fees.

(2) A twenty dollar (\$20.00) administrative charge will be imposed to cover Airport costs incurred in processing Non-Sufficient Funds (NSF) checks.

(3) Aircraft operated pursuant to contractual agreements with San Bernardino International Airport Authority will be assessed a landing fee of \$1.00 per 1,000 pounds CGLW.

**FAA and City Fire Department regulatory requirements must be satisfied prior to issuance of Permit. Permit does not exempt fuel flowage fees. Self-Fueler Permit requirements and/or fees can not be waived.

 ** Includes Airport Staff to block aircraft and operate stair truck, overtime charges not included (one operation is one use to load OR unload personnel from aircraft).
- (9) Surplus Soil Purchase
 (a) Surplus Soil (500 cubic yard min.).....*minimum* \$50 per cubic yard
 (b) Surplus Asphalt or Concrete Grindings (250 cu/yard min.)...*minimum* \$1.00 per cubic yard
 Note: All soil purchases require execution of a License Agreement.

Group III:	126 to 158 feet.....	\$900.00
Group IV:	159 to 199 feet.....	\$1100.00
Group V:	200 feet and larger.....	\$1300.00

(18) Airship Tiedown..... \$125.00
(more than 2 hrs, not to exceed 24 hours – airship operator to provide mast)

(19) Fuel Flow Fee – A \$0.03 per gallon flowage fee will be assessed on all Jet Fuel and Aviation Gasoline purchased by all Airport Fueling Agents and Self-Fuelers. An additional \$0.03 per gallon flowage fee will be assessed on all Jet Fuel and Aviation Gasoline purchased for use in aircraft not assessed a Landing Fee pursuant to Section 3, above. Remittance of fees and copies of all fuel invoices are due to the Airport no later than 15 days after the end of the month or a 10% late fee will be assessed.

Refunds for all or partial fuel flowage fees may be obtained from the Airport Authority as per the terms and conditions set forth in valid operating agreements or leases.

(20) U.S. Customs Service User Fees

Fees Based on Aircraft Weight (CGLW)

500 – 5,000 lbs.	\$ 50.00 per arrival or departure
5,001 – 12,500 lbs.	\$ 125.00 per arrival or departure
12,500 – 35,000 lbs.	\$ 225.00 per arrival or departure
35,001 – 100,000 lbs.	\$ 325.00 per arrival or departure
100,001 – 255,000 lbs.	\$ 425.00 per arrival or departure
Over 255,000 lbs.	\$ 525.00 per arrival or departure

Regular service hours are Monday – Friday, 0830 – 1630 hrs PST. An after hours fee of \$50.00 per hour will be applied in addition to the standard User Fee specified above.

(21) Automobile Parking Rates

Public parking in the Terminal Parking Lots will compensated per the following rates:
