## **JOHN DEERE 5310 IMPLEMENTS**

### **INVITATION FOR BIDS**

The Inland Valley Development Agency (IVDA) is hereby soliciting sealed bids for a Loader Bucket, a Backhoe with a 14" and a 24" bucket, and a Rotary Broom Sweeper that meet the General Specifications for implements to a John Deere 5310 Tractor. The tractor has a 4x4 transmission, a vertical exhaust manifold, front tire size: 12.5-20, rear tire size: 16.9-28, and a Product Information Number (PIN) of \*LV5310S330103\*. Bids are due at IVDA's Administrative Office located at 294 S. Leland Norton Way, San Bernardino, CA 92408, by 2:00 pm on October 14, 2008. No bids will be accepted after this date, and it is the responsibility of the Bidder to insure that any bid sent through the mail arrives on time. All bids shall be made to the attention of the Clerk of the Board, and boldly marked "John Deere 5310 Implements". Telegraphic and telephonic bids will not be accepted. The IVDA reserves the right to reject any or all bids and to waive any informality or possible technical defect in the bid. ### **TERMS AND CONDITIONS**

- 1) Bids must be submitted via the Pricing Page, Affidavit of Non-Collusion Page, and Conflict of Interest Pages supplied by the IVDA in this bid packet. All forms must be filled out completely and signed in order to be considered.
- 2) The price quoted by the Bidder in the space marked *Grand Total Cost* shall include any and all taxes, fees, charges, and costs whatsoever involved. The *Grand Total Cost* will represent the amount that the IVDA will pay to take ownership of said equipment, in a completed and fully installed operational state, upon delivery to the IVDA.
- 3) All Bidders must be prepared to deliver said product on or before December 5, 2008 after official notification of successful bid. IVDA anticipates notifying the successful bidder no later than December, 2008.
- 4) The Bidder's signed proposal and written acceptance by the IVDA shall constitute an agreement.

## IMPLEMENTS SPECIFICATIONS

The attachments shall be new, and shall meet or exceed the specifications listed below.

1. **John Deere 522 Front Loader (For a 5310 JD Tractor):** Bucket shall be of heavy duty construction and have a minimum width of 85 inches. Bucket shall include a level indicator, a hood guard, and all necessary couplings, hoses, and connecting arms. Bucket shall also include a Quick-change attachment carrier. Bidder shall connect the Front End Loader hydraulic lines to the Tractor's rear remote hydraulic couplings. All hydraulic hoses that run underneath the tractor or that are in proximity to the hot engine area shall be wrapped in stainless steel braiding.
2. **John Deere 49 Backhoe (For a 5310 JD Tractor):** Backhoe will include one (1) 14" Heavy Duty Bucket and one (1) 24" Heavy Duty Bucket. Backhoe must have a minimum 9ft. reach and must be able to swing a full 180 degrees (90 degrees from center.) Implement will include an operator station with necessary levers, a 5310 Sub Frame, and a hydraulic power beyond coupler kit. Backhoe shall also include reversible stabilizer pads for quick conversion between field and street usage.
3. **Rotary Angle Broom:** Rotary angle broom shall be attachable to the John Deere 522 front end loader arms of a John Deere 5310 Tractor. Broom shall be a minimum of 60 inches in length and have a minimum of 32 inches in diameter. Broom shall include a universal skid-steer mount, ability to manually change broom angle to 30° left or right, and include fold away stands. Broom bristles shall be of poly/wire type. **Rotary broom shall also include a PTO driven external hydraulic kit to power the broom. The kit's hydraulic tank shall not be mounted above the PTO as per the manufactures recommendations. Bidder shall make provisions to mount the tank remotely as to not hinder normal operation of tractor and all implements.** Said hydraulic kit shall be rated to produce a flow rate of at least seventeen (17) gallons per minute at an engine speed of less than 2,200 revolutions per minute.

### **Installation:**

Vendor shall perform a complete installation of all 3 implements and test for proper functionality. Installation shall be performed with the highest quality of workmanship and parts. John Deere 5310 Tractor and all purchased and installed implements shall be delivered to the IVDA upon completion of installation.

Vendor has the option of performing installation of implements at the San Bernardino International Airport Maintenance Yard or at vendor's location of business. Prior to commencement of work or picking up of the tractor, vendor must provide a Certificate of Insurance showing proof of physical damage coverage for "equipment of others" while in the care, custody, and control of the vendor. A minimum limit of \$100,000 per item is required. The certificate must also show proof of General Liability coverage with

minimum limits of \$1,000,000 Occurrence and \$2,000,000 Annual Aggregate. Vendor shall name the IVDA/SBIAA as additional insured and provide a copy of the appropriate additional insured endorsement with the Certificate of Insurance. Vendor agrees to indemnify and Hold Harmless the IVDA/SBIAA from any claim, loss, damage or expense in any manner, including personal injury or theft occurring in connection with the transportation and possession of IVDA property. Coverage must be with a reputable insurer having an A.M. Best rating of A VII or better.

**Manuals:** A manual or manuals containing illustrated parts lists, operation instructions, safety precautions and routine maintenance procedures shall be furnished with each unit at time of delivery.

**Warranty:** Successful bidder shall warrant the above equipment to be free from defects in design, materials, or workmanship for a period of not less than one (1) year. A copy of the warranty shall be furnished at the time of delivery.
