ADDENDUM NO. 3

TO ALL PROSPECTIVE BIDDERS:

The following revisions shall be incorporated into the contract documents for subject project.

1. Page BD-1, fourth paragraph, ninth line, the phrase “between page BD-15 and page BD-47” is amended to read as follows: “commencing with page BD-15 and through and including page BD-51”.
2. Section 5, page BD-3 is deleted.
3. Section 7, page BD-4, the date of June 10, 2010 is amended to read June 17, 2010.
4. Section 9, page BD-5, delete the word “MANDATORY” in the first paragraph; third paragraph, add the following phrase: “or who are otherwise known to the Agency or who have requested such information from the Agency”
5. Section 12, page BD-6, seventh line, the phrase “10 percent of the total base bid amount (the “Bid Price”)” is amended to read as follows: “10 percent of the total of the (i) bid amount as set forth on page BD-25 of each bidder proposal, (ii) the bid amount of Alternative No. 1 as set forth on page BD-26, (iii) the bid amount of Alternative No. 2 as set forth on page BD-29, and (iv) the bid amount of Alternative No. 3 as set forth on page BD-31(collectively, the “Bid Price”).
6. Section 13, page BD-7, last paragraph, last line, the date of June 10, 2010, is amended to read June 17, 2010.
7. Section 17, page BD-8, is amended by the addition of the following text as a new third paragraph.

After the Bidder’s Proposals are publicly opened and read, they will be compared on the basis of the summation of the products obtained by multiplying the estimated quantities shown in the proposal by the unit bid prices. If a Bidder’s Proposal contains a discrepancy between unit bid prices written in words and unit bid prices written in numbers, the unit price written

in words shall govern. The Agency Engineer and the Agency staff shall submit a written recommendation to the governing board of the Agency identifying the lowest responsible bidder based upon an evaluation of all Bidders' Proposals.

8. Section 20, page BD-9 is amended in its entirety to read as follows: The Bidder's Proposal shall include the Base Bid, Alternative No. 1, Alternative No. 2 and Alternative No. 3 and the lowest responsible bidder will be determined on the basis of the combination of the total of all four (4) separate dollar amounts as noted on the amended page BD-31.
9. Section 21, page, BD-9, second paragraph, is amended in its entirety to read as follows:

The lowest responsible bidder to which an award may be made shall be determined on the basis of the combined bid amounts for the Base Bid, Alternative No. 1, Alternative No. 2 and Alternative No. 3 as previously defined as the Bid Price. However, the actual award and approval of the Project Contract to the lowest responsible bidder will include the undertaking of the Base Bid and all or any combination of the Alternative No. 1, Alternative No. 2 and/or Alternative No. 3 as determined by the Agency at the sole discretion of the Agency based upon the availability of funding at the time of the award of the Project Contract. Such funding availability shall be determined at the sole discretion of the Agency. The Project Contract may include or exclude certain Alternatives for which the Agency may elect to delete or add to the Project Contract in conformity with the dollar amounts contained in the lowest responsible bid as awarded by the Agency

10. Section 21, page BD-10. first paragraph, delete the last sentence.
11. Section 21, page BD-10, second paragraph, add the following to the end of the last sentence: “, and such Bidder shall execute the final form of the Project Contract substantially in the form as provided in the Bidding Documents within ten (10) calendar days after the receipt of the final form of such Project Contract for the Base Bid and such number, if any, of the Alternative No. 1, Alternative No. 2 and/or Alternative No. 3 as may have been awarded by the Agency at its discretion.”
12. Page BD-31 is amended as attached hereto to include a summary for the Base Bid, Alternative No. 1, Alternative No. 2 and Alternative No. 3 and the total of the Bid Price to be forth in words and in numbers, as noted therein. (see attached page BD-31-Addendum No. 3).
