INVITATION FOR BIDS

The Inland Valley Development Agency (IVDA) is hereby soliciting sealed bids for three (3) full size four door, 1/2 ton, two wheel drive pickup trucks with a six foot (6') bed that meet the Truck Specifications noted below. Bids are due at the administrative offices of the IVDA located at 294 S. Leland Norton Way, Suite #1, San Bernardino, CA 92408, by 2:00 PM on Friday, September 29, 2006. No bids will be accepted after this date, and it is the responsibility of the Bidder to ensure that any bid sent through the mail arrives on time. All bids shall be made to the attention of the Clerk of the Board, and boldly marked "Truck Bid." Bids received via facsimile transmission or via telephone will not be accepted. The IVDA reserves the right to reject any or all bids and to waive any informality or possible technical defect in the bid. TERMS AND CONDITIONS

- 1) Bids must be submitted via the Pricing Page and Affidavit of Non-Collusion Page supplied by IVDA in this bid packet. In order for submitted bids to be considered, all forms must be filled out completely and signed and notarized as noted.
- 2) The price quoted by the Bidder in the space marked *Grand Total Cost* shall include any and all taxes, fees, charges, and costs whatsoever involved. The *Grand Total Cost* shall represent the amount that IVDA will pay to take ownership of said vehicle upon delivery to the Inland Valley Development Agency.
- 3) All Bidders must be prepared to deliver said product on or before seven (7) days after official notification of successful bid. IVDA anticipates notifying the successful bidder no later than Thursday, October 12, 2006.
- 4) The IVDA is a public agency; therefore California Exempt Department of Motor Vehicles (DMV) license plates shall be required.
- 5) The Bidder's signed proposal and written acceptance by IVDA shall constitute an agreement.

TRUCK SPECIFICATIONS

The trucks shall be new, and shall meet or exceed the specifications listed below:

1. CAB/CHASSIS: The chassis shall be full size, ½ ton and two wheel drive. The cab shall be four-door. The truck shall be equipped with six (6) full sets of keys.
2. ENGINE/TRANSMISSION: The engine shall be gasoline. The gasoline engine shall be rated to produce at least 190 brake horsepower. The transmission shall be an automatic.
3. BRAKES: Power Brakes required.
4. AIR CONDITIONING: Required.
5. RADIO: Required.
6. STEERING: Power Steering required.
7. PAINT-COLOR: Preferred color is white.
8. INTERIOR: Preferred interior colors are gray or black.
9. SEATS: 60/40 preferred.
10. SPARE TIRE AND WHEEL: Required.
11. WARRANTY: The truck shall be warranted “bumper-to-bumper” for a period of at least five (5) years or 75,000 miles.
12. MILEAGE: The truck shall have no more than 250 miles on it upon delivery.
13. PAYMENT: Payment will be made within 30 days after the following conditions are met:
 - a. Acceptance of the trucks by the IVDA.
 - b. Receipt of an Invoice.
14. BEDLINER: Required.
15. BEACON: Yellow rotating on top center cab required.
16. TOWING: Truck shall be equipped with a class 4 trailer hitch 7 pin wiring harness, and shall have a Gross Combined Weight Rating (GCWR) of at least 10,500 pounds and a towing capacity of at least 6,500 pounds.
17. AIRBAG CONTROL: Required.
18. BED: Shall be six feet (6’).
